- ii) That the name of the Trustee will be 'PRISCILLA VAZ TRUST' having its Principal Office at 125, S.B. Gorai Road, P.O. Asansol, P.S. Asansol (S) Dist. Burdwan.
- iii) That the trust will install school, colleges, according to the decision of Board of Trustee in the name of St. Judes ^{High} School and if in any way extended its object to start college the same will be styled as St. Judes College.
- iv) That the Board of Trustees will primarily start school from Nursery to Senior Secondary after getting affiliation from the Board either CBSE or ICSE and the medium of the School will be english and the name of the school will be St. Judes ^{High} School, Asansol.
- v) That the Board of trustees shall take all decisions in respect of the funding of the school, college, formation of governing bodies of school colleges and to take all decision to propogate educations after taking resolutions thereto.
- vi) That the Board of Trustees are entitled to acquire properties in the name of the trust or the school according to their decision and whatever properties acquire in the name of the school or of the Trust shall be deemed as the property of the trust and none of the individual of the Board of trustees shall have any right to claim as owner of any of the property of the trust or of the school.

It is declare that in the event of death of any of the number of the Board of Trustee in his place the living Board of Trustee may include a name as a member of the Board of Trustee and the said member of trustee will be experienced with all the provisions incorporated with the Trust.
11. That the Board of Trustees will decide in their meeting selecting the names of the nationalised Bank to have accounts in the name of the Trust.

It is also agreed that the Board of Trust is also authorised to maintain accounts in the name of the school styled as 'St. ^{High}Judes School' situated at different places.

It is also agreed that all the properties in respect of the school and colleges are to be as to the property of the Trust.

IN PARTIAL MODIFICATION OF THE DEED OF TRUST executed on 26th Day of June, 2012; **THIS AMENDMENT** is made on this the 2nd Day of January, 2016 with retrospective effect from 26th Day of June, 2012 stipulating the following additions to the Original Deed of Trust dated 26/06/2012 as under:-

That while preparing the said original Deed of Trust on 26/06/2012, inadvertently nothing has been mentioned about dissolution of the Trust and future provision of its activities and/or assets and investments;

NOW THEREFORE, it is hereby mentioned that in case it becomes necessary to wind up or otherwise determine this Trust for whatever reason, neither the settlor nor his/her heirs nor the Trustees for the time being nor any other person shall have any manner of right over such funds of the Trust or any other property.

The net funds and other assets, if any, after meeting all liabilities will be handed over to any other similar Trust or Institution similarly satisfying requirements of the Income Tax Act, 1961 as may be decided by the last Trustees subject further to the conditions that it shall be so given to an Institution as approved by the Commissioner of Income Tax or Director of Exemptions as the case may be.

AND WHEREAS all other Terms & Conditions envisaged in the Original Deed of Trust dated 26/06/2012, shall remain unaltered. And this instrument of amendment shall be considered as an integral part of the said Original Deed of Trust executed on 26/06/2012.
